Educators' Forum Aims to Transform Postgraduate Training

In a new addition to The National, this year APMA is partnering with the American Board of Podiatric Medicine (ABPM) to present an Educators' Forum. The two-part forum spans four hours this afternoon and is perfect for residency directors and anyone involved in postgraduate training. The goal: to modernize the educational experience for podiatric residents.

"Being a residency program director is a tough, more-than-full-time job," said Lee Rogers, DPM, president of ABPM, chief of podiatry at University of Texas Health Science Center at San Antonio, and a member of the faculty for the forum. "We heard from residency directors that there was a need for this kind of forum, which would be inclusive for the entire program's faculty."

"Conflict is a productivity-killer and negatively impacts resident training. I'd be surprised to find a single program in the country that hasn't had to deal with some conflict, between faculty, between residents, or between faculty and residents. I will present the most effective ways of resolving and de-escalating conflict."

"Most podiatric residency directors and teaching faculty are clinicians and not educators," said APMA Trustee Patrick DeHeer, DPM, a member of the faculty for the Educators' Forum

The National's Surgical Blitz sessions are back by popular demand! This year, two sessions, one this morning and one tomorrow morning, explore Forefoot and Soft Tissue procedures and Rearfoot surgery. *The National Today* spoke with Dyane Tower, DPM, MPH, MS, senior medical director and director of Clinical Affairs at APMA and one of the track leaders to learn more about what attendees can expect from these rapid-fire sessions.

THE NATIONAL TODAY: Why are these blitz sessions such a compelling format? Can you explain for our readers how they differ from some of the other surgical track formats?

DR. TOWER: The surgical blitz sessions are a great format to pick up quick tips about a particular surgical treatment/procedure. They are intended to provide the audience with tips and pearls that can be used next time you have one on your surgical schedule. These sessions don't go into the history or diagnostic aspects of a condition or surgery but look to provide a helpful nugget of information for the next time you pick up the scalpel.

SURGICAL BLITZ SESSIONS: FOREFOOT AND SOFT TISSUE AND REARFOOT

THE NATIONAL TODAY: What pearls do you think attendees will walk away with?

DR. TOWER: I believe attendees will walk away with pearls related to patient selection and surgical approach for a variety of conditions.

THE NATIONAL TODAY: Why should podiatric surgeons attending *The National* attend the surgical blitzes?

DR. TOWER: There are lots of topics covered in short bursts, so you'll pick up a variety of pearls.

THE NATIONAL TODAY: What else should attendees know?

DR. TOWER: This is a fast-paced session with topics changing frequently [every 10 minutes]. You'll walk away with new ideas. ●

and director of the PMSR/RRA at Ascension St. Vincent Hospital in Indianapolis. "The time has come for a paradigm shift in podiatric postgraduate medical education. We need to educate the educators on the research about teaching. We demand evidence-based medicine for our patients; we should do the same for the next generation of podiatric physicians and surgeons."

The Educators' Forum will cover a variety of topics, from creating a psychologically safe learning environment to conflict management to emotional intelligence. These topics were chosen based on evidence that a supportive learning environment in which residents are not afraid to ask questions, express concerns, or acknowledge mistakes produces better educational outcomes.

Other topics include running a journal club, teaching in surgery, and remediation. "The forum consists of several practical topics presented by leaders within the profession," said Dr. DeHeer. Panel discussions will give presenters an opportunity to share examples of "how I do it" from their own experience as residency directors. "If you attend this session, you will be able to implement strategies on the following Monday to make you a better educator," Dr. DeHeer said.

Residency directors and faculty, as well as educators from other phases of podiatric medical education and training, will benefit from attending this outstanding new session. ●

Breakfast Symposium Tackles Pain Management for the Post-Op Patient

According to the Substance Abuse and Mental Health Services Administration (SAMHSA) National Survey on Drug Use and Health, 9.7 million people misused prescription pain relievers in 2019. With an opioid crisis still looming large, appropriate postoperative pain management is an important consideration for every podiatric surgeon.

During today's Breakfast Symposium 2: Postoperative Patient and Pain Management, Michelle Butterworth, DPM, and Daniel Hatch, DPM, will tackle this complex topic. The speakers will discuss effective pain management and alternatives to opioids and will also examine how podiatrists can mitigate risk in dealing with postoperative patients.

"We'll give physicians a variety of

options to avoid the use of opioids," said Dr. Hatch. "We will cover multimodal pain management options, and attendees will take home pearls for dealing with opioid utilization."

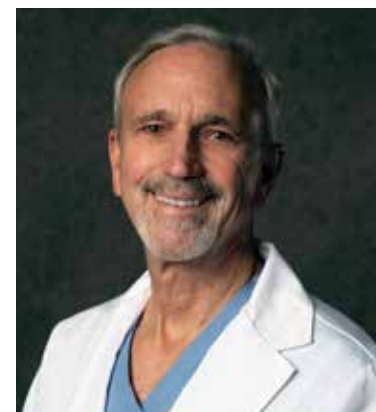
Dr. Butterworth will share advice on minimizing legal risk with surgical patients. "Documentation in the medical record is so important," she said. "I'll provide risk management recommendations including pre-operative assessment, setting patient goals,

identifying risk factors such as comorbidities, and documentation pearls."

"This will be a great session on pain management issues and the medicolegal ramifications," Dr. Hatch concluded. ●

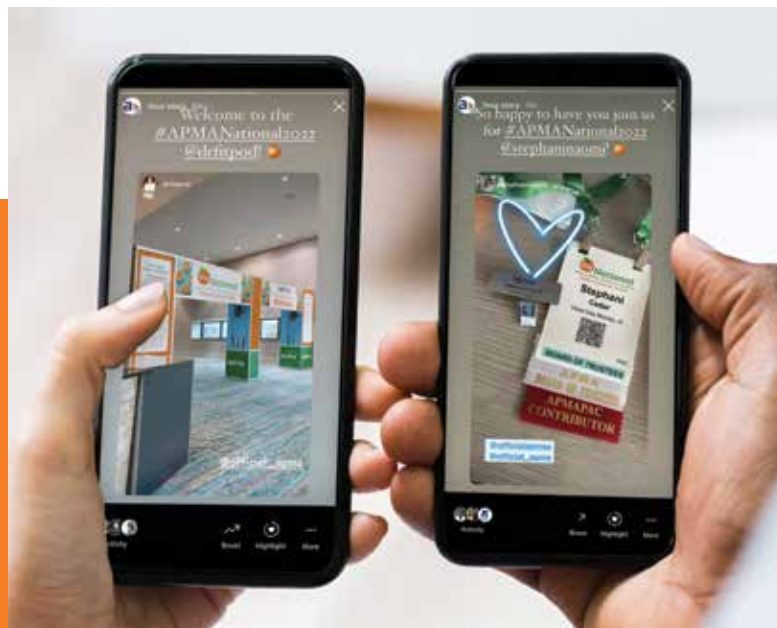

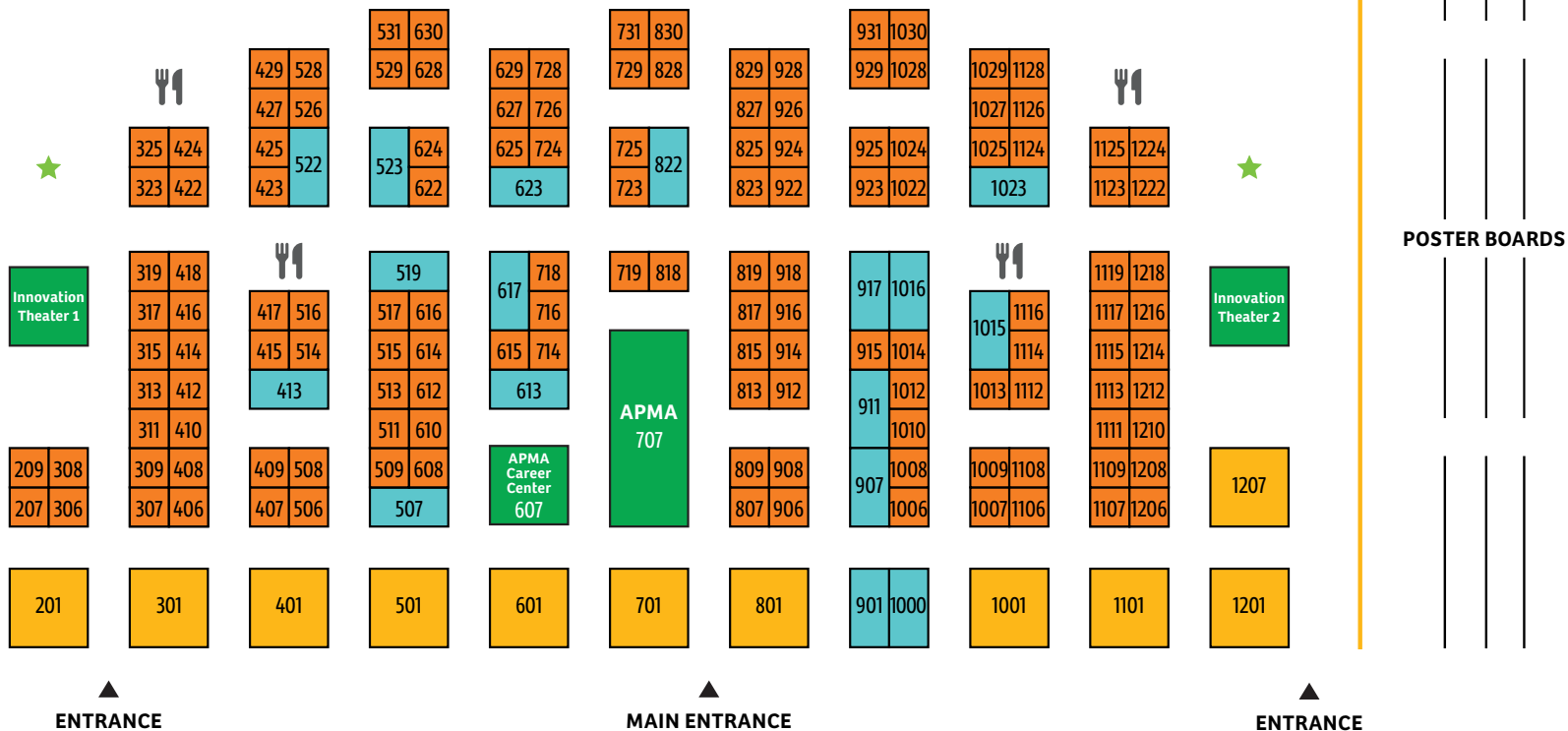
